All of the above are active members and have agreed to serve, if elected. All of the positions on the Board of Directors are open for further nomination and election at the AGM.

President's Report – Philip Welch

To date, it has been a cold, frosty, and generally inhospitable winter, and the University Administration seem to have taken their cue from the weather in their dealings with Dalhousie Retirees and Pensioners.

With regard to the shortfall in pension indexation, at the top of the list of our concerns, I sent a copy of the motion passed at the ADRP General Meeting in December, to Mr. Floyd Dykeman, Vice President for External Relations, on the 7th of January.

The motion reads as follows:

"That the ADRP requests its members, and all other Dalhousie Retirees and Pensioners, to consider reducing or eliminating their undesignated donations and bequests to Dalhousie until such time as the ongoing shortfall in the indexation of Dalhousie pensions is settled."

I indicated to Vice President Dykeman that he might be surprised to hear of this concern, and its expression, and offered to meet and discuss this problem with him. Copies of the above motion, with similar offers to meet and discuss, were sent to the Editor, Eagle's Eye Newsletter; to Ms. Katherine Sheehan, Assistant Vice President, Human Resources; Mr. Jim Cowan, Chair, Board of Governors; Administrator of the Castine Funds; and Level YY Chan, President, Alumni

Association. None of these additional recipients have responded.

I did receive a letter from Vice President Dykeman in mid-February, reminding me that "the indexation issue is highly complex involving a complicated formula", and also that "we all have the same interests in Dalhousie being one of the best Universities in Canada". My offer to meet was not mentioned, but he went on to hope that we will "reconsider the decision to withhold [financial] support" and "continue to support Dalhousie's reputation in the community as this is critical to our ongoing success".

In my response to Mr. Dykeman (27th of February), I reminded him that the monies in the Retirees' Trust Fund (RTF) can only and exclusively be used for the benefit of retirees and their beneficiaries.

My letter went on as follows -

"The University Administration currently insists that the large surplus in the RTF be assigned in its entirety to defray the deficit and financial liabilities of the University's Pension Trust Fund (PTF) for its current employees. This enables the Administration to reduce, to the maximum extent possible, the over-matching contributions to this Employees' Pension Fund, which the University is required to make in order to gradually pay off that deficit. So long as this procedure is applied, Dalhousie pensioners will continue to receive no consideration whatever regarding the 7% shortfall in the indexation of their pensions, until some uncertain time after the {continuing annual} assignment of the RTF surplus has completely negated the PTF deficit.

With the continuation of this procedure, Dalhousie retirees and pensioners will become increasingly frustrated, irritated, and angry at being disadvantaged in this manner. If, as you suggest, the University Administration wants to see Dalhousie rated as one of the

best universities in Canada, I respectfully suggest that the Administration cease ignoring and disadvantaging its own retirees and pensioners. In the present situation, in addition to the likely loss of significant donations and bequests from retirees, which will increase as the retirees' anger and dissatisfaction spreads around, the knowledge of this attitude and behaviour of the University Administration towards its own retirees will also spread into the broader community, tarnishing the public image and reputation of Dalhousie University in a manner and to a degree which will not be easily restored."

I apologize to the readership for including so much detail of the correspondence on this matter, but I do feel that ADRP members deserve a clear and simple exposition of the problem, and a clear description of exactly what the University Administration is doing with the pensioners' monies in the RTF surplus.

For a further illustration of the value placed on retirees by the University Administration, I refer readers to the report of the ADRP Benefits Committee in this newsletter, with regard to the Dalhousie Blue Cross Health Care Plan.

I do feel that the University Administration is finally showing some concern about their manipulation of the Dalhousie pension monies leaking out into the broader University community and into the public domain. I also believe that this concern, and any inclination to take some remedial action, will be increased if ADRP members, and all others concerned, write, call, or email members of the senior administration, such as Vice Presidents Dykeman and Burt and Assistant Vice President Katherine Sheehan. Pick up your pen, phone, or go to your email, and take action now. Tell your friends what is happening. Letters indicating your change of heart with regard to bequests and donations to Dalhousie will also help the vision of the University Administration in this matter.

Treasurer's Report - Bob Rodger

I'm delighted to report that 93 Members had paid their 2008 dues by February 26th. That's twice the number that had paid by the same date in each of the last two years. But there is still a good way to go!

I calculate that there are over 200 Members who have not yet paid their 2008 dues. The \$20 for 2008 was due on January 1st 2008, and ADRP By-Law II.8 says 'Membership terminates if dues are not paid by 31 March.'

Benefits Committee Report - Om Kamra

Blue Cross Medical Contract:

We are currently comparing the new contract, line by line, with the old contract (2003 / 2004) to see if any changes

unknown to us have been made.

- i) <u>Nursing home care</u>: As noted in our December 2007 report, the nursing home care provision has been eliminated, though no premium-paying member of the plan was officially informed.
- ii) <u>Surviving spouses of a deceased retiree</u>: The provisions for continued membership in the Dalhousie Blue Cross Plan by surviving spouses of the deceased retiree members have also quietly disappeared.
- iii) Other changes: When the detailed comparison of the new and the old contract has been completed, the ADRP members will be given an update.
- iv) <u>Obligations of Blue Cross and University Administration</u>: The University Administration does not appear to feel any need to inform premium-paying members of the Plan when important benefits are deleted. The ADRP Board may be seeking legal advice on this matter.

<u>Please note</u>: The ADRP has been repeatedly denied representation on the University Employee Benefits Committee. Members may want to write or call the Assistant VP (Personnel), 494-3700.

We urge the ADRP members not to withdraw from the Dalhousie Blue Cross Medical Plan before investigating alternate Medical Plans (e.g. CAA, CARP) that meet their needs.

STOP THE PRESS – HEALTH NEWS! – Philip Welch

Subsequent to the Report of the Benefits Committee in this Newsletter, documenting the disappearance of the Blue Cross Retiree survivor benefit from the Dalhousie Blue Cross Contract, we wrote a letter of protest to the University Benefit Office.

We have now been informed that this deletion was an unintended error! - which was then followed by another - an incorrect insertion on survivor benefits in the Retirees Blue Cross Information Booklet. We have been told that the previous Retiree Survivor Benefit will be reinstated in the Contract - and presumably corrected in the Retirees' Information Booklet - but we have not yet seen the wording.

We presume that some letter of clarification/explanation will be sent to Dalhousie Blue Cross retiree members. Meanwhile, we will continue our comprehensive review of the old & new Dalhousie/Blue Cross contracts, together with the Dalhousie Blue Cross Booklet for Retirees. Stay tuned for more!

AIKENS, Harry Forbes – 1923-2008 (February 17). Harry attended Dalhousie where he graduated with a Bachelor of Arts degree. He went on to attend Yale University, obtaining a Master of Arts, specializing in Linguistics and Phonetics. Harry relocated to Bordeaux, France, where he taught English for two years. At the invitation of Dalhousie University, Harry returned to Halifax to become a Professor of French and Linguistics, specializing in Phonetics. In addition to French, Harry was fluent in Spanish, German and Italian. He was also an avid philatelist, loved to play the piano, listen to music and enjoyed photography. Harry is survived by his wife Val and several nieces and nephews.

STOKES, Lawrence D. – 1940-2007 (December 24). Larry was born and raised in Toronto and graduated with a B.A. (Honours) in 1962. A prestigious Woodrow Wilson Scholarship enabled him to continue his studies at Johns Hopkins University in Baltimore, where he received his M.A. and Ph.D in 1964. In 1967, he began a rewarding career at Dalhousie University, teaching modern German history until his retirement in 1998. Larry's scholarly research and writing led to the publication of several books on the history of Germany during the Weimar Republic and the years of National Socialism.

Larry is survived by his wife Erika, daughter Kathrin, 4 grandchildren, a brother and sister.

PROPOSED BY-LAW AMENDMENTS

To amend the By-laws by deleting Article III. MEETINGS. Section 8 which reads "CONDUCT OF BUSINESS. Subject to these By-laws Roberts (sic) Rules of Order shall govern the conduct of business" and substituting as By-law Article VII. PARLIAMENTARY AUTHORITY. Section 1. "The rules contained in the current edition of Robert's Rules of Order Newly Revised" shall govern the Association in all cases to which they are applicable and in which they are not inconsistent with the Memorandum of Association or these By-laws and any special rules of order the Association may adopt".

RATIONALE: This proposed amendment follows the wording recommended in the current edition – the 10th published in 2000.

To amend the By-laws by inserting "the Immediate" before Past President in Article IV – ELECTION, REMOVAL AND DUTIES OF OFFICERS AND DIRECTORS. Section 1. DIRECTORS.

RATIONALE: To clarify which Past President is the Officer concerned.

To amend the By-laws by changing Article VI. COMMITTEES, Section 3. LIAISON TO THE BOARD. To read "The Chair of each Standing Committee shall be an ex-officio member of the Board".

RATIONALE: The replaces "Chairman" by "Chair". Robert's now recognizes the use of "Chair"; pp.22-23

To further amend By-law Article VI. COMMITTEES in Section 3 by adding after "....a member of the Board" the following words – "In the absence of the Committee Chair the Committee may be represented by a designated alternate member".

RATIONALE: At present, some Committees have co-chairs although co-chairs are not included in the By-laws. Robert's says "The anomalous title of 'co-chairman' should be avoided, as it causes impossible dilemmas in attempts to share the functions of a single position." P.168 The existence of co-chairs for some committees but not for others has not yet caused any "impossible dilemmas". The creation of co-chairs has affected determination of the quorum at Board meetings and eligibility to vote. The aim of the amendment is to ensure that a Board Committee has the authority to ensure that, in the absence of its Chair, the Committee can be represented at the Board of Directors meeting. Board meetings remain open to ADRP members whether or not Committee members.
